In 2017 more than 200 customers were served,

both new and repeat business providing quality work and service. INDOT extended their contract with new vehicle wraps. Additional core business included **signage & banners** for realtors, construction, events and more.

Growing partnerships for situational assessments and trial work experiences provided 81 referrals and 19 job placements of individuals with disabilities.

Sewing Manufacturing
255,000 garments were produced in
2017 for the Dept of Defense and other local commercial companies which included coveralls, Chef coats, smocks, canvas bags and pouches. New offering of free industrial sewing classes to individuals with disabilities.



Packaging & Assembly

2,155,140 packages & assembled parts were produced in 2017 serving 11 customers. New jobs included sorting candy by flavor, packaging Guitar/Uke picks, make-up sponges, assembling necklaces, packaging shelving clips, assembling stamp blocks and more.



Electronic Recycling

74.500 lbs of electronic waste was processed over 9 months. After review, a decision was made to focus our resources on our other core services. A janitorial training program began in April, and the recycling program was discontinued.

Children Services



Childcare

Geminus Head Start Preschool & Early Head Start programs increased by 10 children with maximum classroom enrollment. Increased one-to-one service for children with severe diagnosed

disabilities. Continued to offer respite services for children.

Speech & Occupational Therapy

With the addition of another therapist TradeWinds is able to provide more services.



Summer Camp

Community-based action-packed program for children of all abilities ages K to 12. Daily fun includes trips to the waterpark, bowling, arts & crafts, plays and much more.

Adult Services



ADAPT— Adult Day Activity Program & Training

The ADAPT program offers a wide range of activities in the classroom along with providing the opportunity to socialize with others in a safe, monitored, caring and supportive

environment. Daily classroom activities plus community outings to the festivals, parks, bowling, restaurants, base-ball games, and other events.

Residential Services

In January a new group home was opened transitioning from an older home. All 6 Group Homes were at or near capacity. All Supported Living facilities were at capacity while searching for new facilities to purchase.



Respite Care

TradeWinds offers caregivers the opportunity for a short-term break a minimum of 3 hours to overnight in their home, TradeWinds' newly remodeled respite apartment, or in the community.
